Several Leaguers met on March 26 and held an interesting and sometimes lively discussion that resulted in our League coming to a consensus regarding the National Popular Vote questions of LWVUS. Since then I entered our consensus results into the LWVUS database to be compiled with results from other local Leagues after which the LWVUS Board will take an official position on NPV. Only after that can our League discuss the results of our consensus!

Need I remind you that we will hold our Annual Meeting next Monday? Please plan to attend!!! Print and bring to the meeting the agenda and budget emailed earlier. Come, enjoy the friendship of our group, and meet the state President and President-elect. Let us talk to them about living in the Four Corners area and the challenge of being a small league establishing a reputation in a poor, rural county. Specifically, what is the value of the state league to us? What do we want the state Board to do for us? For each, what has been the most rewarding and memorable League experience?

Do you have any strong thoughts regarding the League name? One of the League list serves has been actively discussing the questions. Please share your perceptions at our annual meeting.

The EPA has rescinded the air permit for Desert Rock Power Plant - at least for the present. Good news! Our League with Eric Janes's leadership and comment paper addressed many of the issues that the EPA listed in rescinding the permit. ....Stay tuned.

Eric Janes and I have been working with LWV

LaPlata and San Juan Citizen's Alliance to address the lack of a strong EPA focus in the Four Corners area. As you know, there are three different regional EPA offices that oversee the Four Corners area and none of the three has a singular focus on FC environmental problems. Eric has written in his usual thorough way a draft proposal for an EPA manager to be located permanently in the area. Once various folks review the draft, the task force will begin to obtain support politically.

Thanks to those Leaguers who participated in Teen Maze this year – one of the best organized and biggest in the country! Thanks to Judy Schuenemeyer for organizing the League's participation each year and for Jack Schuenemeyer for the before and after "ballot questions" participants answer when entering and exiting the maze. Jack also created very informative posters about the history of voting in the US that hung in the League area.

Thanks to the following for helping with the League booth: Judy and Jack Schuenemeyer, Marcia Boon, Eleanor Kuhl, LuAnn Burkett, Lorna Wilkes, Betty Janes, Chris and Jodi Foran. I also saw Leaguers Terri Helm and Llois Stein helping with the Maze in another area. Thanks folks!

Eleanor and I are attending LWVCO Convention in Golden, May 16 and 17. More later about what we experience. At the Annual Meeting, you'll have an opportunity to question Marjie Beal, Patty Cordova, Eleanor and me on issues.

I'll be emailing separately a Resolution to the Board by LWV Larimer County on Health Care Reform. Let's plan to talk about it at the Annual Meeting.

## **Summary of our 2008-2009 League Year**

While we are a small and relatively newly chartered League, – presently 26 members – we have been able to establish a presence in Montezuma County and to encourage informed and active participation in government for both our members and citizens of our County this past year.

This has occurred in part because so many of our members are active in other community activities and because many League members have participated in and supported League activities.

### **Voter Service**

- A core focus of the League is Voter Service, an ongoing activity.
- We encouraged teachers at our three high schools to use League developed curriculum on the Presidential election printed for us by the Cortez Journal.
- We participated in M-CHS voter information program.
- We made twelve informational presentations to community groups on Colorado ballot issues.
- We raised community funding to provide our 2000 English ballot pamphlets and 300 in Spanish.
- We held a Legislative Lowdown forum with our legislators that was standing room only.
- We held a well attended Candidate Forum.
- We participated in Teen Maze using a post experience “vote” using actual county provided voting booths.

- Our website had links for various election web sites

### **Climate Change**

- In October, we sponsored with the aid of LWVUS grant the visitation of Dr. Kristen Averyt who is a UN IPCC scientist who helped to write its report. Dr. Averyt detailed the scientific process of gathering and analyzing data regarding climate change. She emphasized the results of the enormous efforts of international scientists to understand climate change due to man's activity.
- During Dr. Averyt's visit, she spoke at three high schools about science as a career for women.
- Dr. Averyt also visited local water managers.
- The League collaborated with Montezuma Climate Action Network to bring Patrick Cummins, Program Director: Climate Change and Air Quality of the Western Governors Association.
- The League attends the Board meetings of local rural electric cooperative and provides the directors with updated articles on climate change.

### **Health**

- Health care legislation and action is a concern of several of our members. We have continued to monitor national and state reform efforts.
- We have initiated an effort with LWV LaPlata to sponsor an October, 2009 Forum on the health problems associated with poor air quality, particularly in the Four Corners Area where the coal fired power plants have impacted us.

## Collaboration

- In spite of our small size, the LWV of Montezuma County has found that it can have an incredible impact on our community by not only offering our own events, but also working with other groups when they share similar positions.
- We have joined a county-wide group for information sharing purposes.
- We alert our members to meetings and activities of other environmental, health and planning groups.
- We have provided the various groups with a form to complete when observing an open meeting.

### Comprehensive Plan

The County is reviewing its Comprehensive Land Plan. The Montezuma County Planning Commission will be conducting scoping meetings focusing on the need to update or rewrite the Montezuma County Comprehensive Plan. The purpose of the meetings is to determine if the vision for Montezuma County is the same as it was when the Comprehensive Plan was adopted or if the vision has changed. ### **Hovenweep Oil and Gas Dump, officially known as the Outhouse Recycling Facility**

On March 26, 2009, the Montezuma County Planning Commission voted to approve the Special Use Permit and High Impact Permit for Nathan Barton (designer and operator) and Casey and Kelly McClellan (land owners and business partners) of Four Corners Recycling to develop a recycling center for O&G drilling waste products.

The County Commissioners, who have the power to grant final approval for these permits, AND issue a Certificate of Designation for a NEW solid waste facility in Montezuma County, will hear from the applicants and community members on Monday, June 1, 2009, at 9:15 AM in the County Annex. They are expecting a large crowd. It is important that you express your concerns at a public hearing where they become public record.

### ***Budget Adoption and Bylaw Changes***

The annual meeting is a time to make any changes and adopt it for the next year.

Please bring to the Annual meeting a copy of the proposed budget emailed earlier to members. Our budget is simple. Individual members pay many expenses. We are fortunate not to have to rent a meeting facility.

Our payments to the state and national Leagues have increased. Additionally, membership per member payment (PMP) for LWVUS will rise for the second year in a row. This particularly affects our individual membership dues. In 2008-2009, we realized only \$4 from each individual membership. In 2009-2010, we will realize only \$2.80, after paying PMP's to LWVUS (\$29.20) and LWVCO (\$18.00). Even so again, your Board has decided not to raise dues for the coming fiscal year.

Loss in income from dues will depend upon additional fundraising or greater contributions in order to support our program.

### ***Health Care at the National Level***

With health care at the forefront at both the state and national levels, LWVUS is working toward the passage of meaningful reform. Additionally, a LWVUS Health Care Education Task Force is educating League members about health care issues. Over the past few months, Task Force members have been drafting papers dealing with a variety of health care issues. Two fact sheets are

now available with several more in process. Our League is planning to hold a forum soon relating to the debated policies and issues as health care reform will be a topic not finalized any time soon.
